#### **EUPJ Search and Nominations Committee**

# Report for the special meeting of the EUPJ European Assembly to be held on 20<sup>th</sup> April 2023

The EUPJ European Assembly, at its annual meeting held on 8<sup>th</sup> September 2022, considered and approved the resolution proposed by the Executive Board (ExBoard) that a search and nominations process be put in place from the date of the 2022 Annual European Assembly (AEA) until 20 April 2023. During that time a pro-active and effective search process would be implemented to find a new Chair and/or co-Chairs for EUPJ as well as nominees to take over the offices of President and Vice-Chair Governance, and also to review the structure and make-up of the Management Committee (MC).

At that meeting it was agreed that Rabbi Thomas Salamon would chair the Search and Nominations Committee (SNC) with assistance from the then EUPJ Co-Chair, Robert Weiner.

Firstly, may I thank Rabbi Salamon for commencing the work of the SNC and contacting a large number of individuals whose names were given to him. I also want to thank Robert Weiner, who began the work with Rabbi Salamon as the EUPJ Co-Chair but who resigned his position in December for personal reasons. Since then John Cohen (Vice-Chair Governance) and I have taken on the task of progressing the work of the SNC and have endeavoured to catch up on the time lost. I am therefore very grateful that Miriam Kramer agreed to be nominated for the position of Chair of the EUPJ, having been co-opted to the MC as co-chair together with Sonja Guentner, which co-option was ratified at the ExBoard meeting on 16<sup>th</sup> March 2023.

Since December 2022, John and I have phoned, corresponded and met by Zoom and WhatsApp a number of excellent candidates whose names have been forwarded to us by Rabbi Salamon and others. We had also circulated a number of requests to EUPJ members as well as members of the ExBoard urging them to continue to suggest potential nominees for these positions. In view of the time pressures and constraints, we sent the proposed list of nominees to the SNC and held a Zoom meeting in early March.

I am delighted that the SNC, the MC and the ExBoard have all agreed to propose the names of the nominees in the list attached as Appendix 1 (the EUPJ Slate) for the positions on both the MC and the ExBoard indicated on the EUPJ Slate to the Special European Assembly (SEA) to be held on 20<sup>th</sup> April 2023. A short profile of all the nominees is also attached as Appendix 2. The SNC believes that those nominated reflect a strong, committed and excellent cross-section of our European communities and will complement the current members of the MC and ExBoard and be excellent successors for those whose terms come to an end at the SEA. I therefore urge EUPJ members to approve these nominations.

There are, however, two issues to which I wish to draw to your attention:-

- 1) At the next Annual meeting of the EUPJ, to be held in August/September 2023, we will have three major vacancies being Chair, Vice Chair- Finance and President unless we find suitable candidates by then. To date we have not received any nominations for these positions.
- 2) At that Annual Assembly we will not have a single representative from the UK on the MC of the EUPJ despite the fact that the EUPJ is a UK registered charity and that the UK has the largest Synagogual Movements in Europe.

With that in mind, Miriam Kramer, on taking on the position of sole chair at the SEA, has kindly agreed to write a letter re-introducing herself and urging further nominations to the MC. This letter will be sent to all members of the ExBoard and Miriam will request that this letter be

forwarded by board members to all the chairs and Rabbis of their member communities with, hopefully, their endorsement and encouragement.

This is especially important because at the 2023 AEA further vacancies will arise and, in particular, vacancies for the Chair, VC-Finance, up to a further two Vice Chairs, up to a further five co-options as well us up to five further Vice Presidents. So there is plenty of scope for further nominations which hopefully will arise with help of our members. Finally, I would like to advise that I have agreed to remain as President of the EUPJ until the 2023 AEA and to help supervise the work of the SNC so that nominees for these positions can be identified.

I would like to emphasise that we, the leadership of the EUPJ, believe in the relevance of the EUPJ in promoting and nurturing Progressive Judaism across Europe and our aim is to ensure that ours is the voice of a vibrant, diverse and meaningful European Judaism and that we are seen as such. With this in mind, the SNC has advised the MC to aim for greater gender, age and geographic diversity when seeking further nominations. In addition, the EUPJ should focus and concentrate on informing its members and communities of the importance, relevance and direction of the EUPJ to all its members, regardless of their size and position. The EUPJ should and will work with its members to achieve its aims and goals in consultation and with the help of its members.

I wish to thank all those who have sent nominations to the SNC, all those who have agreed to be nominated, the members of the SNC and Rabbi Salamon in particular and my colleagues on the MC.

So, the SNC, as approved by the MC and the ExBoard, is requesting the EUPJ membership to approve the resolutions set out in Item 4 of the Notice of Meeting calling the SEA and to which this Report is attached. These resolutions (a) extend the period of operation of the SNC to the date of the 2023 AEA; and (b) approve the appointment of the persons in the EUPJ Slate for the positions on the EUPJ MC and/or ExBoard set out next to their names

#### **Management Committee and Executive Board - Profiles of Nominees**

#### **Andres B Mosquera**

I am 57 and working for NATO as a civil servant, where I am the top lawyer at NATO's Supreme Headquarters in Mons, Belgium. I am a member of the Reform Jewish Community of Madrid and while Expat in Belgium member of the IJC. I just came from Israel after teaching international law last academic quarter at Reichman University, Herzilya.

I am very interested in contributing to the EUPJ project for Progressive Judaism in Europe in general and in southern Europe particularly. I think I can be of great help to EUPJ due to my Jewish leadership and Jewish traditions studies (Beutel Jewish leadership course of 2017 and courses on Jewish literature in the US and Argentina - I am also the author of several disclosure articles (in Devarim and Nueva Sion) in Spanish and Portuguese, which is my contribution on explaining Reform Judaism to the Spanish and Portuguese speaking shulls in Europe and America. #### František Fendrych

For 23 years, from 1997 to 2020, I was the vice-chairman of the Reform Jewish Community in Děčín.

In 2000, we founded in Prague, with the spiritual support of rabbi Thomas Salamon, the Jewish Liberal Union, ZLU, which in 2002 became a member of the World and European Unions for Progressive Judaism (WUPJ, EUPJ) and was also admitted to the Federation of Jewish Communities in the Czech Republic (FJC) but only as a associated member until now. I was the founder and long-time chairman of the ZLU.
