- (3) Associate Members Associate Members may appoint one Delegate each to attend the meeting, but such delegates are not entitled to vote. An Associate Delegate Appointment Form is attached as **Schedule 2** and must be completed and returned to administrator@eupi.org as soon as possible but by no later than 25 August 2023. Each Associate Delegate will then receive an email link to the Zoom meeting by no later than close of business on 25 August 2023, and this link must not be shared.

- (6) Proxy A Constituent Delegate who is unable to attend the meeting of the European Assembly, may appoint a proxy to attend and vote in his/her place provided that notice of intention to appoint a proxy has been received by the Administrator at the above address not less than 48 hours prior to the start time of the meeting.
